Market Committee Resolution no (4) for year 2007 concerning the meeting dates of the listed companies' general assemblies and the dates of dividends distribution.

According to the above mentioned Resolution, each listed company shall:

- 1- Hold its general assembly at the end of its financial year and during 45 days from the date of the market's approval on its annual financial statements.**
- 2- Distribute cash and share dividends to shareholders within ten working days from the date of approval issued by the company's general assembly.**
